Explanation of increases in the budget:

COLA 8.7% verbally promised across-the-board to all employees by Supervisors--additional 7% "Back the Blue" to Sheriff and Deputy Sheriffs; also had significant impact on the Supplemental Funds asking for additional FICA/IPERS on these wage increases
