Sheriff Todd Johnson discussed the benefits of getting a new jail video visitation kiosk. This is an option that comes with the new jail phones. There would be many benefits to using the video kiosk including not having to lock the jail area down during visiting hours, and may possibly open up more visitation times throughout the week. Discussion was held about possible locations for the kiosk.

Engineer Mitch Rydl gave Secondary Roads update. He presented figures/options on purchasing an excavator this year instead of a snow removal truck due to the truck not being in stock for a couple years and the excavator being available this year.

Colleen Porsch and others representing the Audubon Soil and Water Conservation District discussed their budget and gave updates on current and upcoming projects.

Jotham Arber with Guthrie Public Health gave the yearly usage report for Audubon County's Public Health Services. He also presented a proposed budget for next year.
