They have hired a Mental Health Practitioner starting July 1st. They are also needing a full-time preventionist. They are needing to teach kids about the dangers of drugs and alcohol. The Recovery Center is contacting the surrounding counties that they work with for any assistance they are willing to give. Audubon County is in the process of starting an Opioid Settlement Funds Committee to discuss what these funds should be used for.
