August 8, 2023

The regular meeting of the Board of Supervisors was called to order at 9:02am by Doug Sorensen. Motion-Thompson Second-Sorensen to approve the agenda. Vote-all in favor.

Department Head Meeting-Department Heads need to remind employees to submit their physical forms on the portal. There is a Bike Trail meeting at the ACED Office Wednesday, August 9th at 5:30pm. This is about trail signage. Hopefully Bruce has been working on applying for grants to help with maintenance/improvements to the bike trail. Kent brought up that the dead ash trees will probably become a problem in 2-3 years if not cut down. Janell Bluml stated that it would be nice to plant trees in place of these that could possibly be donated with memorial signage.

Phone call with Justin Veik of Engineering Technologies, Inc. to discuss the HVAC project. Justin has received responses from a few contractors, so hopeful for some bids. Justin will schedule another courthouse walkthrough with interested contractors. Planning on receiving bids in September. The Board will have another phone call with Justin next Tuesday, August 15th at 9:00am. The HVAC project will be an 11-12 month process. We will need to use some office space at the old Audubon State Bank building. Recorder Bills will email everyone a spreadsheet to complete with their office space needs. Treasurer Campbell will check into possibly using a DOT Mobile Unit instead of moving everything in the Treasurer's office.

Assessor Janell Bluml stated that she is wanting to rent a garage for \$25/month for her vehicle; since purchase, vehicle has been parked at the fairgrounds where it gets very dirty. The Board agreed to the garage rental. Jennifer Keller's last day was 8/7/23. Janell has received some applications to fill her position. It may be possible that the Assessor's office will have to change their open hours this fall because of staffing.

Discussion with Chris Swensen and Mitch Rydl regarding Board of Adjustment and three vacancies. Mitch will be contacting new members and have a resolution ready for next Tuesday approve appointments accordingly.

Chris has received the IPERS audit regarding the township trustees/clerks pay through payroll as opposed to accounts payable. He will come up with a response to IPERS. Lisa discussed with Chris the correct coding for fixed assets. There will need to be some journal entries to correct coding.

Engineer discussed Public Hearing next week for the Proposed Development Agreement with Hamlin Feed Mill, LLC. Two of the bridges on F32 should be open by next week.

The Board stated to go ahead and pay the FY24 allocations to Elderbridge, Good Neighbor Service, and Audubon Homebound Meals. They still want to hear from Elderbridge in the near future to discuss any changes.

Jared Hershberger, APEX Clean Energy, presented their future project plan called Coyote Willow Wind. This project would be the erection of wind turbines in Southwest Audubon County operating in year 2029. They will be in that area talking with land-owners.
