The meeting of the Board of Supervisors was called to order at 9:04 am by Chairman Heath Hansen. Motion- Thompson Second- Hansen to approve the agenda. Discussion was held on the approval of the FY25 allocations to Elderbridge, Good Neighbor Center, and the libraries within the county. Motion- Thompson Second- Hansen to approve FY25 allocations to Elderbridge and Good Neighbor Center. Vote-all in favor. The amount that was previously allocated for the Kimballton library, which closed, will most likely be distributed between Exira & Audubon. The amounts will be decided on next week. Motion- Thompson Second- Hansen to approve the meeting minutes of 7-9-24. Vote-all in favor. Motion- Thompson Second- Hansen to approve claims as submitted by various departments to be paid in the amount of \$551,638 and published in a separate publication at the end of July. Vote-all in favor. After last week's Department Head meeting, the overall discussion and input favored the decision to utilize a Compensation Board. Motion- Thompson Second- Hansen to approve the Compensation Board Resolution 2024-41 as follows. Vote-all in favor.

RESOLUTION #2024-41 ESTABLISHING A COUNTY COMPENSATION BOARD

A resolution by Audubon County to establish a county compensation board as authorized by Iowa Code Section 331.905.

WHEREAS, pursuant to lowa Code Section 331.905, as amended in 2024 by Senate File 2442, the county board of supervisors may vote to establish a county compensation board.

WHEREAS, pursuant to this same Code Section, when the board of supervisors establishes a county compensation board, the compensation board shall be comprised of seven members who are residents of the county. Two members shall be appointed by the board of supervisors, one member each by the county auditor, county attorney, county recorder, county treasurer, and county sheriff. The members of the county compensation board shall not be officers or employees of the state or a political subdivision of the state and shall serve staggered terms.

WHEREAS, terms of incumbent elected officials were used for members of the county compensation board. **NOW, THEREFORE, BE IT RESOLVED,** Audubon County hereby establishes a county compensation board for the county.

BE IT FURTHER RESOLVED, Audubon County directs each of the elected officials to submit their respective appointments to the board of supervisors by October 1, 2024.

BE IT FURTHER RESOLVED, the representatives of Auditor, Sheriff, & Board of Supervisors shall serve an initial term of four years and the representatives of Attorney, Recorder, and Treasurer shall serve an initial term of two years. **BE IT FURTHER RESOLVED**, this resolution shall apply retroactively to July 1, 2024.

RESOLVED FURTHER, that the executed Purchase Agreement and conveyance document(s) are hereby accepted and approved by this political subdivision, and Lisa Frederiksen, Auditor, is hereby directed to deliver the executed Purchase Agreement and Easement to the lowa Department of Transportation Right of Way Agent, or their duly authorized representative, in exchange for the consideration of 1,450.00 and other valuable considerations, all as authorized in accordance with the Code of Iowa.
