Blane Kerkhoff called the meeting to order at 9:15 A.M.

The minutes from the previous meeting, September 9, 2025, were reviewed. No changes were needed. Blum made a motion to approve the September 9, 2025, meeting minutes. Osvald seconded. All approved. Motion passed.

Henkle gave a brief introduction of all those present; Heath Hansen was representing the Audubon County Board of Supervisors.

Henkle started the discussion of the Urban Renewal Amendment and passed to Heath Hansen to explain the reason for the Urban Renewal Plan Amendment. Hansen then passed to Rydl to explain the new projects more in depth.

Rydl explained how the Road/Bridge/Culvert project was something he had originally planned to use federal funds for but shifting those federal funds to a different bridge project in the future and using the UR funds to pay for this bridge/culvert project. He also explained the Courthouse parking/alley improvement project (South & East sides of the Courthouse) and how the handicap accessible curb would also be fixed during this project.

The group discussed in depth how the County is not taking on any additional debt by adding these projects to the Urban Renewal Plan; only using funds they already have from a bond years ago. The group discussed how adding these projects to the plan does align with the Audubon County 2022 Comprehensive Plan (Chapter 6).

Blum made a motion to approve the October 2025 Urban Renewal Plan Amendment for the Audubon County Consolidated Urban Renewal Area. Osvald seconded. All approved. Motion passed.

Rydl discussed and gave updates to the group on some upcoming projects already in the Urban Renewal plan.

Osvald motioned for the meeting to be adjourned. Blum seconded.
